## **Tennessee Reconnect**

#### What is Tennessee Reconnect?

Tennessee Reconnect is a last-dollar scholarship that provides free tuition for adults to attend a community college. The initiative is designed to help adults enter college to gain new skills, advance in the workplace, and fulfill lifelong dreams of completing a degree or credential.

#### **Eligibility requirements:**

- Haven't earned an associate or bachelor's degree.
- Have been a Tennessee resident for at least one year.
- Complete the Free Application for Federal Student Aid (FAFSA) and be determined as an independent student.\*
- Be admitted to Columbia State and enroll in a degree or certificate program.
- Must attend at least part-time (6 credit hours).

In order to maintain the Tennessee Reconnect grant, students must enroll in classes leading to an associate degree or certificate, maintain a 2.0 GPA and continuous enrollment. Adults who meet all the requirements will receive a last-dollar scholarship, which is equal to the difference between tuition and fees and any gift aid (grant and scholarships) that a student receives.

### Apply for Tennessee Reconnect:

- 1. Apply to the Tennessee Reconnect program.
- 2. Review the Reconnect Success Plan once the application has been submitted.
